Certificate of Approval - First-aid training and qualifications

Health and Safety at Work (Northern Ireland) Order 1978

Health and Safety (First-Aid) Regulations (Northern Ireland) 1982

1. In pursuance of regulation 3(2) of the Health and Safety (First-Aid) Regulations (Northern Ireland) 1982¹, the Health and Safety Executive for Northern Ireland (HSENI) hereby approves for **1 year** from the date of this Certificate:

(a) the training given in first-aid by **Emergency First Response**
of **Unit 7, St Phillips Central**
Albert Road
Bristol
BS2 0PD

(hereafter known as the organisation) at suitable premises in a course which complies with the provisions set out in Schedules 1 and 3 of this Certificate and which leads to a certificate in first-aid; and

(b) the training in first-aid given by the said organisation in a course which complies with the provisions set out in Schedules 2 & 3 to this Certificate and which leads to the award of a certificate in first-aid or to an endorsement on a certificate in first-aid already held.

In either case following training approved by the Department of Enterprise, Trade and Investment for the purposes of the Health and Safety (First-Aid) Regulations (Northern Ireland) 1982.


2. The qualification awarded in first-aid:

- (a) is valid for three years;
- (b) is evidenced either by a certificate in first-aid awarded by the said organisation or by an endorsement on a certificate in first-aid already held, following training approved by the Department of Enterprise, Trade and Investment for the purpose of the said Health and Safety (First-Aid) Regulations (Northern Ireland) 1982; and
- (c) is gained following the passing of an examination which complies with the provisions set out in Schedule 4 to this Certificate.

3. The approval given in paragraph 1 of this Certificate of Approval relates to any case where standard training in first-aid and a suitable qualification in first-aid are sufficient for a suitable person for the purposes of regulation 3(2) of the Health and Safety (First-Aid) Regulations (Northern Ireland) 1982.

4. The qualification mentioned in paragraph 2(b) must be obtained not more than three years after a qualification in first-aid which itself was evidenced by a certificate in first-aid or an endorsement on a certificate in first-aid following training in first-aid approved by the HSENI for the purposes of the Health and Safety (First-Aid) Regulations (Northern Ireland) 1982.

5. This Certificate of Approval is also subject to the provisions of Schedule 5 to the Certificate.
